

Minutes of Greenville Annual Town Meeting

June 1st, 2026

The meeting was opened at 6:00 pm by Town Clerk, Tammy Firman who offered the Officer's Return and Greeting. There were 67 persons in attendance with 62 being Greenville voting-eligible.

The Pledge of Allegiance was led by Tammy Firman.

Nomination, second and election of a Moderator, Mr. Jonathan Pottle of Katahdin Law LLC in Bangor, Maine was accepted. The Moderator presided over the remaining business of the Town Meeting.

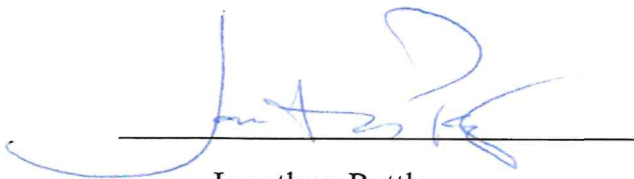

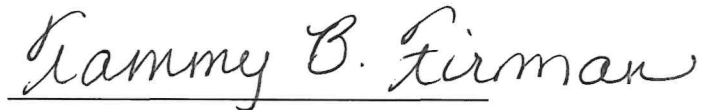
Article 50. Motion was made and seconded to approve Article 50 as recommended. Article was approved.
